# Estonians trapped by the

Rich Estonians who invested in the real estate of the Black Sea seaside resort in Varna, Bulgaria, with hopes of fat profits, were scammed by the local Chechen criminal gang, writes today's Äripäev.

Estonian developers were digging in Armenia. Others lured to this land of miracles by Ahmed Ozdoyev, a former convict who brought together Estonians and local Chechens in Varna and, together with the Chechens, charged skyhigh commissions from Estonians.

"I recall that we did it in style - we withdrew a lot of cash from the bank, flew there with over 100,000 euros in pockets, and paid for the land," says one businessman who was lured to Bulgaria by Ozdoyev and had set up joint ventures Družba-3 and Tchaika 2007 co-owned by people who were linked to the Chechen organised criminal group in Varna.

"Their objective was somewhat dubious. They controlled prices so well that we could not understand whether they realistically invested any money there or not. In principle, they used our money to become owners," said another Estonian shareholder of Družba-3.

Three-four years ago life in Estonia was beautiful - the economy was expanding and the real estate boom promised bigger riches. Free funds were itching in Estonians' pockets. Some of them believed the fairy tales of Gild investment bankers and invested in gold

believed the tales of Ahmed Ozdoyev, a well-dressed Ingushian, about the town of Varna at the Black Sea and other nearby resorts.

"I know everybody there and will help you buy land cheaply," was Ozdoyev's main message, according to investors.

#### **Investors unconcerned** about Ozdoyev's prison record

So Estonians started to throw in the Varna area. money in the wind. There were those who withdrew all retained profits from their small business and invested it in the Bulgarian real estate market, hoping to earn millions in profit.

Surprisingly, no-one seemed to care that Ozdoyev had recently been released from prison where he had spent several years for involvement in organized extortion when attempting to take over one food industry at the end of

Anyone could have done a simple background check and found from the Internet a few articles published at the end of 1990s that said that Ozdeyev who was being charged at the time was the leader of the Ingushian mafia in Estonia. However, none of the businessmen said they were bothered by the criminal record of their partner. On the contrary, they hinted that this was even a benefit to go into the new market with such hardened partners since you don't beat up your own guys.

In Varna, Ozdoyev had set up contacts with Jahia Hashiev who, according to the Bulgarian media, is the leader of the Chechen criminal group

The background of Hashiev is so colourful that one could turn it into a blockbuster movie. Among others, he has served years in prison for extensive VAT fraud, and is claimed to have links to the top people of the Irish Republican Army (IRA) who have invested large amounts of money in the real estate market of Eastern Europe. In addition, his partners include people who the Bulgarian law enforcement agencies suspect of organizing prostitution, drug business, extortion and smuggling of weapons.

Hashiev who is escorted by five bodyguards was arrested again by the Bulgarian police in March 2010, has been charged of extortion and is waiting trial.

Things started to move quickly for Estonians who had followed the advice of Ozdovev and travelled to Varna with wads of cash. Companies were set up in Bulgaria and, just in a few days, various land parcels with houses or sometimes simply fields were registered to their names.

It were the Chechens who selected land parcels and negotiated prices with sellers. In some cases they also became co-shareholders with Estonians in the companies set up in Bulgaria. According to local journalists, the new business partners of the Estonians were well-known in Bulgaria as members of a criminal gang.

#### The Chechens asked top price from the Estonians

The scheme how the Chechens operating in Varna filled their pockets with cash from Estonians was simple. Depending on the amount of possible investment, they chose the lots or developments and told the sellers to write into sales contracts prices that were several times higher than actual prices.

Among others, they bought for Estonians lots near the Ignatievo village that is of

suspect value and is inhabited with gypsies. They paid sellers 2 euros per square metre, although the price stated in

the contract was 18 euros. "Locals believe that they were laundering money, but it could actually have been simply a scam against Estonian partners," said Rositsa Penkova, a journalist in Varna who helped Äripäev with the story. It is unusual in Bulgaria to show a higher than the actual price in the contract. Those keen to evade taxes are doing the contrary, showing a smaller price.

These land transactions for Estonians were masterminded by Umalt Osmaev who was a close associate of Hashiev and who himself became a coshareholder with the Estonian in Družba-3.

One of the land sellers told a Varna journalist later that he could not understand why they wanted to buy his land since it was impossible to build anything on it.

"They were buying the land to re-sell it at a profit," said the local resident who sold his property.

Several Estonians who had been attracted to invest in the Varna area can tell similar stories. One person who wants

#### How the article was prepared

► Äripäev spent over six months investigating business connections of criminals and Estonian businessmen in Bulgaria. ▶ We started to investigate the case on the information found in the Bulgarian business registry last year that the business partners of several Estonian businessmen who had a business in Varna were persons who were known as members of local Chechen criminal gangs. ▶ The investigative article of Äripäev is based on information collected from many sources in Bulgaria and Estonia, various documents and data from the Bulgarian registers. ▶ We also used materials published in the Bulgarian press about the local Chechen criminal gang who had had contacts with the leaders of the Irish Republican Army (IRA). ▶ In collecting information, we were assisted by two Bulgarian journalists. ▶ The preparation of the article was financed by the European Fund for **Investigative Journalism** (www.journalismfund.eu) ▶ The same fund supported the preparation of an extensive article on money laundering in Bulgaria whose traces also came to Estonia. The article was published at the beginning of this year by Äripäev.

to help Estonians who got scammed in Bulgaria and who knows well different organised crime groups said that one in ten people who get scammed dare to speak out. The rest hope for a miracle or are simply afraid. Also he himself wished to remain anonymous.

Speaking of Ingushian criminals in Estonia, he said that their representatives may not be among the ten most influential criminals in Estonia, but they are famous for such scams.

"There are claims that the local Ingushian gang in Estonia and the Bulgarian Chechen gang are linked. This claim is being made by people who have been successful in business and those who have had problems with them. But it must be said that these people - Ingushians and Chechens are quite arrogant," he added.

It should also be added that the Bulgarian investigative journalist who works in a local media company and helped us with the case said when Äripäev asked to describe Hashiev that Hashiev was too dangerous and preferred to remain anonymous.

What is the secret of Ozdoyev that he has managed to scam so many Estonians and why did he generate such trust? Those who have met him say that he is a good communicator, but also mention prominent (Estonian) businessmen who, according to Ozdeyev, were in business with him.

Data from Bulgarian registers and websites shows that the company of Ozdeyev is linked to the company of Andres Saame, founder of Hansabank, that is involved in large development in Golden Sands near Varna. Another person linked to this project is Härmo Värk, former CEO ofSampo Pank.

#### Prominent businessmen created trust

Äripäev sources said that Ozdoyev emphasised in all possible times his joint Also Pille-Triin Urb did business with Saame and not wish to comment his Värk.

Värk admitted to Äripäev that he had met Ozdeyev. Hearing that Ozdeyev had attracted several Estonians to Bulgaria and mentioned the names of Värk and Saame as his partners, Värk starts to laugh and says that he did not know about such advertising.

But there are also other prominent Estonians involved in the real estate business in Varna. Bankruptcy trustee Andres Hermet and notary Aivar Mesikäpp have business interest there. "I have met Ahmed Ozdoyev, but he did not take us there directly nor recommended any partners. Since he was also in Estonia,

we simply discussed matters," says Mesikäpp.

In several companies where Ozdoyev is a partner, there are two Estonians who should be mentioned: Ahti Lille, former prominent tax official was convicted for accepting a bribe, and Gunnar Urb, owner of Seiklusjutte maalt ja merelt, a wellknown pub in Tallinn. The latter is the brother of Pille-Triin Urb, wife of Ozdeyev who himself lives in an apartment in Kadriorg that belongs to

Gunnar Urb did not wish to answer Äripäev questions saying that they were biased. husband.

Ozdojev himself that he has not brokered any real estate proejcts to Estonians. He claims that he does not Andres Saame and Härmo Värk, although Värk says otherwise. He also denies knowing Jahia Hashiev.

Investors who Ozdoyev attracted to Bulgaria to invest in local real estate say that it was Ozdoyev who set up contacts with Hashiev. It is claimed that Ozdoyev and Hashiev are now in conflict since the money that Estonians were paying for property did not always reach Ozdojev.



Ozdojev helps Saame to do business

Ahmed Ozdoyev, an Ingushian who lured Estonians into Bulgaria and into the arms of the local organised criminals, has in a strange way also become a cooperation partner of a company that belongs to Andres Saame, a founder of Hansabank. Namely, the company owned by Ozdeyev and Ahti Lille, a former highranking tax official convicted of bribery, is selling luxury apartments co-developed by Saame.

The apartment building known as Amfora Palace is located in the Golden Sands near the Black Sea not far from famour resort, the town of Varna.

About three years ago it was acquired together by Toompeamaja in which Andres Saame has a large shareholding and by Satnam Europe, an are illegal investment company managed by Härmo Värk, former CEO of Sampo Pank, that invests the funds of a limited number of wealthy foreign investors into Estonia and elsewhere in Europe.

The purchase of this lucrative waterfront development under lucid trees is shrouded by secrecy.

Estonians who do business in the Varna area claim that Ozdoyev spent months in looking for buyers for this development.

This means that someone had to arrange a meeting between the Ingushian, Saame and Värk, but this is where the information ends.

#### Saame is quiet and his business partner fiddles

Einar Entsik, a long-time business partner of Saame and the managing director and one of the owners of Amfora Palace, at first denies that the purchase deal was mediated by Ozdoyev.

When we asked him about the claims that Ozdoyev helped the deal to succeed, Entsik decided to leave things open: "Frankly, I would not comment at all about the identity of the person who gave us le. information. Let's leave it this

According to Entsik, they were looking for specific investment possibilities and received all kinds of offers.

Do you know Ahmed Ozdoyev? "I more or less know everyone who does something in this area," said Entsik who is keen to say nothing specific.

Rositsa Penkova, a journalist based in Varna, described Amfora Palace as follows: "It

incomprehensible how Amfora Turs (the company that owned the development before the Estonians editor) succeeded in securing the building title and destroy many trees."

After Estonians took over the development with 137 apartments, they badly needed a partner to manage the sale of apartments. Under contact information, the website of Amfora Palace has an e-mail address, a Skype number, etc. of Baltic House. The owners of Baltic House are Ozdoyev and his business partner Ahti Lille. Strangely, Ozdoyev denies knowing either Saame or Värk and says that he has only read about them from the papers. However, according to one source, it was none other than Ozdoyev who proposed to Saame and Värk that apartment sales could be handled by Lil-

The claims of the Äripäev source are verified also by Härmo Värk himself. "I have met Ozdoyev, but I don't really know him or his business or other activities. I know that he is a partner of Ahti Lille. But I cannot really say what Baltic House or Ozdoyev specifically do," says Värk.

Like Ozdoyev, also Lille has had problems with law. In 2005 a court judged found Lille guilty of having accepted



over 300,000 kroons in bribe as head of the first North department t h e investigation arm of the Tax and Customs Board. The court sentenced him into prison for four months. We now found Lille in Bulgaria selling apartments belonging to a company of prominent Estonian

#### Also Lille starts to fiddle

businessmen.

At first Lille tries to evade the questions about Amfora Palace, but finally admits that "there is a cooperation contract between business enterprises Baltic House and Amfora Palace that are both incorporated in Bulgaria."

Entsik has no criticism to Lille. When asked how he met Lille, Entsik says that when you start doing something in one area, you will develop a circle of contacts and Lille was one of those persons who live there.

Entsik summarises the whole discussion as follows: "We are not very public persons, as you have seen. We don't have any major announcement. Yes, we have been developing it for a few years now. At this pace there will be another two or three years, and that't it.

Speaking about his business partner Andres Saame, Entsik said that it would be futile to contact Saame since he was not commenting anything anyway.

# "Hašiev is a small shifty guy, but a good communicator"

An Estonian who invested in the Varna area in Bulgaria and agreed to give us an interview if we did not disclose his name talks about his conflict with Ahmed Ozdoyev and meetings with Jahia Hashiev.

The following is the interview with this Estonian real estate developer.

#### How did it happen that you started to operate in Bulgaria and how did the problems start?

I am slightly embarrassed since I have been a fool myself. It started when Ahmed Ozdoyev invited one of my friend to Bulgaria and I and my friend started a business there. One day when I was sitting in Varna in a restaurant. Ozdovev entered a neighbouring restaurant and invited me to his table. I knew him by face and had seen him on a plane. He told me that he is Ahmed and offers all Estonians who operate in Varna his assistance for a fee. In other words, he was offering a racket and said that nothing happens without

I gave him three reasons why I planned to pay him on money: first, it was the way to do business in early 1990, not today. Secondly, I have never paid a cent to any crook and, third, he may want to get money from the Estonians, but I am a setu, not an Estonian. He said that he understood and added that I would undoubtedly rethink...

#### Is Ahmed Ozdoyev one of the leaders of organised criminal group in Estonia or in Varna?

A mob leader?! Have you seen him? He is an ordinary

#### So there is someone in Estonia who is his boss?

Yes, Dikajev. Haron Dikajev is his boss, the actual leader of the Chechens. Ozdoyev is just an ordinary nut in this system. I have heard from Estonians who have purchased something from Bulgaria and Ozdoyev was asking 10% holding in everything. He claimed

joke. I never paid him a cent.

#### **But how did Ozdoyev know** about your business in **Bulgaria?**

It was through one of my companies, Rahe Bul. Moreover, you can count the Estonians who realistically do something in this region on the fingers of one or two hands. We had said hello to each other before.

#### How did the problems in your Bulgarian business arise?

My mistake was to buy two apartments in Bulgaria and since he (Ahmed Ozdoyev editor)... Well, now it becomes exciting! Since I was lazy and did not wish to spend all my time in Bulgaria and two prominent businessmen had purchased a large complex there and Ozdoyev was somehow involved ...

#### Are these two persons who have an apartment building near Varna Andres Saame and Härmo Värk?

Yes, they purchased a large complex on the Golden Sands near Varna. And then they somehow put Ahti Lille, former high ranking tax official who had been sentenced to prison, in charge. I don't know how, but must have been through Ozdoyev. Ozdoyev is such a soft guy, a slippery chap and does not look like a crook at all. I was always laughing that while in the old days crooks were carrying golden neckchains, he had replaced it with a shiny laptop computer.

### What does Ozdoyev look

Well and expensively dressed, undoubtedly paid for money he has stolen from his customers. So no jumpsuit as in the old times. Dressed all in white, like those big crooks usually do.

#### So you bought these two apartments in the building owned by Saame and Värk?

No, it was a different location. But the reason why I started to talk about Saame and Värk was that they employed Ahti Lille who was that he knows the situation recommended to them by was wrong.

and protects everybody. What a Ozdoyev. Lille had just been released from prison and I met him in the town. He talked normally and said that he has no future in Estonia after spending time in prison and that he is now selling apartments in the building of Saame and Värk and is doing a honest job.

He was the only Estonian who was living there constantly for months. I was planning to sell my two apartments and thought that if Värk and Saame trusted Lille, and they are normal white people, so can I. I agred with him that he would get 10% of the sale price if he sold the apartments. We set up a separate company and I registered the apartments to the name of the company and he became member of the board. There was a clause that apartments can be sold only if shareholders agree.

What happened them is worthy of a movie script, but it is fact that Ahti Lille sold these apartments and kept the money. He forged my signature as owner, went to the notary and sell them. Later, when I heard about it, I met him in Bulgaria. He came together with two goons and said that the thing was that Ozdoyev had taken the money away so I need to speak with Ahmed.

He claimed that Ahmed had told him to give him the money. I taped this conversation. I told him that I had no intention to keep listening this imbecile talk and said that I was going to the police. Then they got scared and asked me not to go and seek a different solution, perhaps buy some cheap land parcel and... I went to the police nevertheless. Bulgarian courts are working very slowly, but surely. The case was for six month investigated and is now in the prosecutor's office as it was determined that the signatures on the sales contract were not mine.

#### Have you after that communicated with Saame and Värk?

After I found out I called Einar Entsik, CEO of their company, and warned them about Lille. I thought that such normal people as Saame and Värk do not hire crooks, but I transaction involves a bank

#### You were blinded by prominent relations of Ahti Lille?

Yes, I was a fool myself that I believed him. Lille told me that Saame and Värk had told him that they had property in different countries and that Lille could become a sales manager if everything goes well in Bulgaria. A nice prospect, his eyes were gleaming. I was thinking myself that a normal person would be unlikely to risk all that.

#### What did Saame and Värk do after your warning?

Their CEO Einar Entsik thanked me, but said that their situation was different since the apartments were covered by a bank mortgage and every representative.

Entsik added that he should **To whom?** find someone else, but that Ahti Lille had been in Bulgaria for a long time and was well informed. He said that they would strengthen supervision over him, but would hardly

fire him.

Six months have passed and I don't know what has happened in the meantime. At least a month ago Lille was still living in their house. So he probably keeps selling and is simply under stricter control.

#### Let's talk about Rahe Bul where you have a holding. How did the associates of Hashiev end up in business with you?

Ozdoyev established a contact between me and Hashiev, but I don't have not had such problems with Hashiev as I have had with Ozdoyev and Lille.

You have met Hashiev? Oh yes.

#### He offered that let's do business together?

It came up in the conversation, but basically it was him who offered it.

#### Are criminals controlling the real estate market in Varna? How is it possible that so many Estonians have been trapped by

No, it's an urban legend and a fairy tale. Simply there are acquaintances, Ozdoyev meets them and tells them that he knows the people, controls the situation, promises the cheaper prices in exchange of 10% holding in their companies. People who are in Bulgaria for the first time listen to him with mouths open. Instead of threatening you, they are sweet-talking.

#### Rahe Bul has purchased land south of Varna at the Black Sea. What is the situation with this land?

The construction has been frozen for a vear.

#### And Matiko-2000, the company founded by Hashiev, is still your part-

Yes, they have 25%. It was 50%, but they sold half.

No, to other Estonians.

My principle is that if it is a normal Estonian, then I will not identify them for the press without him knowing it. It would not be polite.

#### You have another company there in Bulgaria - Est Estate.

Yes. It owns a land parcel in Varna, without buildings. It is simply waiting its time.

#### Your partner there is bankruptcy trustee Andres Hermet.

Yes, he is a very normal person, we know each other for years.

#### Aren't you afraid that you could lose your whole investment?

No. As for Hashiev, he owns 25% of Rahe Bul, but there are laws that offer enough protection.

#### But he has damaged your business already by fiddling prices when buying the property?

This is the time when I should look into the mirror.

#### May I ask how much you invested in Bulgaria?

The two apartment alone cost over 100,000 euros.

#### But including the land? I am embarrassed to say the

#### What kind of a man is Jahia Hashiev?

He is a small shifty guy, but a good communicator. He is also dressed in white,

#### like Ozdoyev?

Absolutely, from head to toe and in white suit. A golden ring, the whole works. Friendly?

Yes, friendly, these days they are all friendly.

#### Is is moving about with a bodyguard?

Of course. He has five of them.

#### **Should the Estonians who** have a conflict with Hashiev or Ozdoyev be worried about their life?

They can threaten them that if you don't do like they say, they would never leave Bulgaria alive, and some may have been afraid. Estonians can be easily intimidated if they don't understand that these crooks are still afraid of the police.

# Ahti Lille: I did not steal, I was helping

Äripäev asked Ahti Lille for comment to claims that he had allegedly stolen the two apartments. Lille denied that he had sold the apartments behind the owner's back and kept the money. He sent his responses to our questions by e-mail.

ategorical answer to your question is that I have not forged any signature. If any of your sources claim it, I suggest that you obtain a verified copy of an expert study report which says that I have forged anything. Such an export study report cannot simply exist. The person who is accusing me now asked me to help him to sell the miserable apartments in question. He told me that he had decided to buy these apartments and made a downpayment for them under the influence of local wine and felt very

bad about his weakness. In parallel he wished to acquire one prospective property. I have personally helped him and arranged for assistance in solving both issues.

This same person had overestimated his potential finances and was unable to finance the property fully. This was the reason why Tallinn Invest (the company of

the Estonian who accuses Lille of scam) lost a lot of money in both 2008 and 2009. At the same time the economic climate continued to worsen and finding free funds in this period was very complicated for many investors.

As to the claim of your source that there is a criminal case opened, I understand that the authorities are simply checking the application, instead of carrying out a criminal procedure. Perhaps I have misunderstood, but before a criminal procedure can be opened, there should be a crime.

## Värk: I know Ozdojev s a person, Ahmed

Ozdoyev was calm and smiling. We met because you are there in this country and you know that people have an office there and you meet them. We also needed bridgeheads and wanted to study who does what and how. I learned about Ahti Lille when Einar Entsik already knew him, since Entsik was initiating this project. Let's say that we (Satnam Europe - editor) were invited to invest there through the office of Einar Entsik and Andres Saame. I believe that we ma-



de the decision together. But they had information that there was an investment opportunity before us. I know that Ahti Lille has had some problems, but the fact that he has been in prison is news to me. You learn to know a person when managing and running the project, but Ahti is generally in charge of sales and is not involved in finances

# "There simply is no money left"



Interview with Horre Saluste and Kristjan Metsur.

#### How did you discover the real estate business in **Bulgaria?**

Horre Saluste: "We had surplus funds. We invested it and lost it."

Kristjan Metsur: "There were many new contacts and in the course of the discussion with different businessmen we came to the idea that Bulgaria was a nice place and we should go there to see whether we can do something."

Saluste: "Real estate speculation was our idea. The principle was very simple: buy cheap and sell at a high price."

#### How much money do you have tied up in these investments?

Saluste: "A few million kroons for several lots near the town of Varna near the Black Sea."

#### You still have these lots that you have purchased?

Metsur: "It's not possible to sell anything there".

Saluste: "There is no market of buyers. Foreigners have gone away. Essentially, they created a bigger real estate bubble that in Estonia."

Metsur: "We will inherit it to our children, as say some people who have also invested

#### Do you have business partners in Bulgaria?

Metsur: "Yes, of course."

#### How did you find them?

Metsur: "In the course of meeting different people and this is how the contacts developed."

Saluste: "Land deals. My neighbour in Kadriorg had large-scale real estate investments there. He practically lured as there. It seemed like a good investment. If I recall then we did it in a grand manner - we withdrew a lot of cash from the bank, flew there with over 100,000 euros in pockets, paid money and got the title to the land."

#### Who selected the lots?

Metsur: "Let's say that local real estate businessmen and some of them became land co-

owners together with us. But their objective was somewhat dubious. They controlled prices so well that we could not understand whether they realistically invested any money there or not. In principle, they used our money to become co-owners."

#### Why did you not evade them? Do they control the whole region?

Metsur: "Well, the whole sales information is under their control. It was difficult to get directly to sellers in good locations."

Saluste: "We did not know the market. The question was whether to trust or not. Many Estonian businessmen have lost their money when they do business in an unknown place alone. Therefore we saw this as the only option."

#### But someone mediated you the local contact in Varna?

Saluste: "No, we already had this contact from Estonia". Metsur: "He had been doing business there for years."

#### Who was that person?

Metsur: "I will not name

#### Was he Ahmed Ozdoyev?

Saluste: "Yes".

#### The people who were your partners in Bulgaria are well known in Varna as mobsters. Does this come you as a surprise or did you check their background?

Metsur: "It is not very surprising. We have heard something like that ourselves."

#### So you simply stumbled on wrong people.

Saluste: "Well, a wolf does not touch a neighbour... Probably something like that. Our relations were actually very good. There was no problem with lack of trust."

#### Are they attempting to scam you out of your money?

Saluste: "Why? There simply is no money any more."

#### Umalt Osmaev, member of the local Chechen gang who is also your partner in the local company Družba-3 did the land deals himself for you, didn't he?

Metsur: "No, we still communicate with them very nicely. We can talk about anything."

Saluste: "They are neighbours".

Metsur: "They took an exceptionally large brokerage fee, and we don't even know how big it was, but that was what they did... So, in this way they fooled us, but..."

#### Did they become coshareholders by their own

Metsur: "We could have been the only shareholders, but we wanted to expand this circle and wanted them to be our business partners and help us to sell the lands later. Let's say that it was partly our wish that they became business partners."

Saluste: "We saw that they had so much influence and many contacts. Regionally, it is always better to do business with people like that than with people who don't know anything about nothing and have no influence."

#### But what about their criminal past?

Metsur: "We did not know that. We did not go anywhere to police and could not have understood local Bulgarian newspapers even if they had written about it. If we had known it, we would not have been buyers."

#### You have also other partners, a fashion businessman Uno Kaseväli and advertising businessman Peeter Pullerits. How did they find

Saluste: "We dragged them in in good faith, like we were dragged in ourselves. But they did their decisions themselves."

#### What will you do now? Wait for better times?

Metsur: "Yes."

Saluste: "Why take out some 100,000 to 200,000 if you have 1990ies any more where invested 5 million in it."

#### So you invested 5 million in total?

Saluste: "The amount paid for this land could total 5 million. But there are Estonians who have lost notably larger amounts there."

Metsur: "This is not our business any more. Why probe him that hey, where are you going to place it? After all, we were not sauna buddies sitting behind a beer and a shashlyk, asking them what they planned to do with the money. We were their good business partners and were able to do things quickly."

#### Can you say that your local partners were looking for simple-minded golddiggers who were willing to give their money to these guys whom they had not background checked?

Metsur: "We did not give them the money. We went to a notary and gave the money to sellers."

#### Saluste: "But perhaps it was They simply handled your business?

Metsur: "Yes, they drew up papers and... Of course, they are not going to help us to sell the land and we must ourselves start looking for buyers. Selling is not yet reasonable."

Saluste: "It's probably a good time to buy land because it is very cheap there now."

Metsur: "Yes, if the Estonian businessmen have faith, it would be a good time to buy. Some people who need money urgently are now selling lands there at a very reasonable

#### And do you recommend to use the same contacts there?

Metsur: (laughing - editor) "Everyone should choose his or her own contacts. We are not going to recommend anyone."

# **Ozdoyev denies** everything

In a telephone interview to Äripäev, Ozdoyev denied that he was linked to Jahia Hashiev and that he had mediated real estate to Estonians.

The man refused to meet us, saying that he had no interest in talking about his activities.

#### Is is true that you are involved in real estate business in Bulgaria?

Yes, I am.

#### Do you offer or also sell to Estonian businessmen local projects and an opportunity to invest in them?

I don't do that. We have our own interest there, but we do not broker.

Bulgarian journalists have linked Hashiev and his associates with the Irish Republican Army (IRA). In addition to IRA, Hashiev is believed to have been in business with the father and son Veselin and Hristo Danev who has had infuential relatives in the Bulgarian ruling elite.

Danevs are being charged
in organising prostitution
and in other crimes. Hashiev
has also done business with
Radoslav Kaltchev who is

► Hashiev has also been the local boxing club. According to Estonians, Hashiev is always escorted by several bodyguards.

#### Matiko-2000 (legal entity)

► Company founded by Jahia Hashiev that, according to a Varna-based journalist, has made over 100 real estate deals. It is claimed that at first transactions with properties are always made between companies and persons linked to Hashiev and only then move to new owners. The company's CEO Stefan Karaivanov is Jahia Hashiev's business partner. At present Karaivanov is being investigated together with Hashiev under extortion suspicion. Matiko-2000 is owned by Tsonka Stantcheva, wife of Hashiev, and someone named Antoanete Tomova.

#### Ettevõte Družba-3 OOD (legal entity)

- ▶ The company is registered in Varna and is co-owned by Estonian businessmen and Umalt Osmaev. In 2007 it acquired a lot of land in the Ignatievo village about 15 km fromVarna. According to the local journalist, the land in question is of low value and the only positive side is relative proximity to Varna. In addition to Osmaev, Družba-3 belongs to the following Estonians:
- ➤ Kristjan Metsur, who is one of the owners of Estonian company Aqualife that attracted media attention when consumers complained

that its salesmen were using dishonest methods for selling its water filters. In addition, Metsur has for years been a real estate broker, most recently for Agenda Kinnisvara.

➤ Horre Saluste is the chairman of several small companies and an actor. Among others, he is a board member in Aqualife where Metsur has a shareholding. Saluste also performs children's theatre plays.

Noorak has been head of the local land authority sinc 2001. Until 2002 he belonged to the supervisory boards of two land surveying companies. In March the court bailiff auctioned his house and property in Kiili municipality. The property has a 8.4 million kroons

mortgage for Marfin Pank.

#### Rahe Bul OOD (legal entity)

- ► The company is registered in Varna and 25% of its shares are owned by Matiko-2000 (initially Matiko-2000 owned 50% of Rahe Bul, but later it was sold to Estonians).
- ▶ Rahe Bul acquired from Matiko-2000 about 3000 square metres of land about 50 km south of Varna at the seaside town Biala. In 2007 when the transaction was made the board of Rahe Bul included Estonian Raul Rannu who owns the company also Stefan Karaivanov who is linked to Hashiev and is currently under criminal investigation together with Hashiev. By now the company's management board has been replaced, but Äripäev was unable to obtain information about the new managers.
- ▶ In addition to Matiko-2000, the shareholders of Rahe Bul at the time of the land deals was Gregori and Partner, a company of And-

res Heliste and Raul Rannu, that had Silver Eensaar as board member.

► Heliste became known

in Estonia when he shortly before its bankruptcy became CEO of the media business of Oliver Kruuda, the owner of Estonia's two large food industries. Eensaar is the long-time lawyer of Julianus Inkasso, a debt collection agency. He has been linked to the business of Endel Siff, one of Estonia's richest persons. When Siff sold his holding in oil business N-Terminal to a secret investor. Eensaar became member of the supervisory board of N-Terminal and the CEO of the buying company. Before its went bankrupt, Eensaar managed L.Rei, the company or Rein Kilk who owns a string of food producers. Eensaar is also the only member of the board of Julianus Grupp.



# **Ahmed** Ozdojev

► Estonian businessmen say that Ozdoyev is a salesman who invited Estonians to invest in real estate in the Varna region in Bulgaria. It is claimed that Ozdeyev cooperated with Jahia Hashiev which is why people linked to Hashiev became business partners of Estonians who were investing in Varna. He himself denies such links. According to one source, the two men are now in conflict with each other. Ozdoyev himself spent

several years in prison for

#### **Ahti Lille**

▶ Business partner of Ahmed Ozdoyev. In Bulgaria Lil-

# **Evelin Vihtol**

▶ She is the co-habitant of Ahti Lille from the time when Lille was charged of accepting a bribe. Vihtol was caught together with Lille as mediator of the bribe. Both were found guilty. At present Vihtol is a shareholder in two companies which are halfowned by Kalev Uustalu, head of the national heritage authority. Another 50% is co-owned by Evelin, Eve and Helen Vihtol.

▶ In the past she was supervisory board member in AS Goodmani Grupp that was liquidated in 2003 and where she served on the board together with Terje Taal who was co-habitant of Janek Klais (known as Martin Raud), a notorious arm and drug dealer.

#### **Gunnar Urb**

► Business partner of Ahmed Ozdovev in Estonia and in Bulgaria. According to Äripäev, Gunnar Urb is the brother of Pille-Triin Urb who is wife of Ozdoyev. The two men co-own

Estbulg OOD in Bulgaria and Mikro Kinnisvara in Estonia. One of the companies of Gunnar Urb is Seiklusjutte Maalt ja Merelt, a well-known Tallinn pub.

#### Pille-Triin Urb Wife of Ahmed Ozdovev.

He works in the Mikro Kinnisvara that belongs to Ahmed Ozdoyev and Gunnar Urb. Her name and telephone number is listed on the company's website under contacts. In the past she has been in the board of several companies. including several years in management of OÜ Piimamees that belongs to Tarvet

Vaik, partner of pop singer Mike Emelai, a convicted drug dealer. Vaik spent over four years in prison and was released in 2007. Until 2005 Urb belonged to the management board of OÜ Mendelsoni Elamispinnad, a company owned by prominent real estate businessman Toomas Mendelson.

► Amfora Palace is a complex of apartments that is about 17 km north of Varna at the

heart of Golden Sands. next to the area's largest waterpark. The company has 137 apartments of different size and a car park under the building. According to the company's website, most of the apartments in

the building are unsold, while 47 apartments have been sold and 17 have been booked. ▶ In 2007 Amfora Palace was founded by Meelis Rihvk who later sold it to Satnam Europe managed by former Sampo Pank manager Härmo Värk (50%), Hansabank founder

Andres Saame (40%) and lawyer Einar Entsik (10%). Andres Saame was one of the founders of Hansabank, Estonia's most successful bank, and for years has been listed among Estonia's richest businessmen. Last year Saame was 192nd with assets of 162 million kroons. At present Saame operates mainly in real estate and owns real estate company Cross Holdings which in turn owns 80% of

► Härmo Värk was CEO of Sampo Pank until 2006 and is a former CEO of Estonian Investment Bank who in 1998 merged with Forekspank to form Optiva Pank.

▶ Since December 2006 until April 2010 Värk was managing real estate investment company Satnam Europe that belongs to Rathbone Jersey Ltd., an investment company registered in the Channel Islands. Last autumn the company's owner changed and it adopted a new name St. Anne's Trustees Ltd. that is registered on the

Guernsey island ▶ Einar Entsik is minority shareholders in Toompeamaja with 20% of

shares. ▶ This year Härmo Värk was replaced as executive of Amfora Palace by Ruben Gornischeff who also became CEO of Satnam Europe and who earlier handled development projects for Uus Maa real estate company. Satnam Europe cooperates, among others, with Paul Oberschneider. Recently they together borrowed 50 million

euros from Swedbank to

refinance their businesses.

#### **Kristoff Invest**

► Aivar Mesikäpp is a prominent notary who is a shareholder in the Bulgarian company Kristoff Invest that was registered in June 2007. In the same year it acquired real estate near Varna from Matiko-2000, a company linked to Hashiev. Other shareholders of Kristoff Invest are Karol Muul and Hindrek Hermlin.

► Mesikäpp started his business as a notary at the beginning of 1997. There are no companies in Estonia where he is a shareholder. but Muul has represented a company that formally belonged to Laivi Mesikäpp, wife of Aivar Mesikäpp. Neither Muul or Hermlin have been particularly active in Estonian business.

#### **Meelis Trading**
